The national finals of the Italian Computer Science Olympiad (OII) will take place in Udine from 23 to 25 September. For the first time, Italy will also host the Balkan Olympiad in Informatics (BOI) in the same venue. The competition, launched in 2000 and involving over 250,000 students to date, is organised by the Ministry of Education and Merit in collaboration with AICA – Associazione Italiana per l'Informatica e il Calcolo Automatico, a long-standing promoter of digital skills in Italy and a member of CEPIS.
