Also, for **doctoral students at Faculty of Economics and Business**, University of Zagreb and **Faculty of Tourism and Hospitality Management**, University of Rijeka, this workshop will be considered as participation in the **first/second research workshop** (as a mandatory activity of the post-graduate doctoral studies programme).
